

COMMERCIAL GENERAL LIABILITY COVERAGE

DAMAGE FROM BLASTING EXCLUSION ENDORSEMENT

This Endorsement Changes the Policy. Please Read It Carefully.

Certain words and phrases that appear in bold have special meaning as defined below or in the Form to which this Endorsement is attached.

The titles of sections or paragraphs listed below should not be considered for purposes of interpreting the intent of this Form; these titles have only been inserted for ease of reading.

This Endorsement is attached to the Commercial General Liability Max Form and is subject to all terms, conditions, limitations and exclusions of such Form.

The following exclusion is added to Paragraph 2. **EXCLUSIONS**, under **SECTION I – COVERAGES, COVERAGE A – BODILY INJURY AND PROPERTY DAMAGE LIABILITY**:

2.24. Damage from Blasting

This insurance does not apply to **property damage** arising out of the use of explosives for blasting.

However, this exclusion does not apply:

- 2.24.1. to **property damage** arising out of work performed on your behalf by any contractor or sub-contractor; or
- 2.24.2. to **property damage** included within the **products-completed operations hazard**.

All other terms and conditions of the Policy remain unchanged.
