DICE PRODUCERS PORTFOLIO MPTV PRODUCERS PORTFOLIO KIDNAP, RANSOM AND EXTORTION COVERAGE

This Endorsement Changes the Policy. Please Read It Carefully.

Certain words and phrases in bold have special meaning as defined below or in the form to which this Endorsement is attached.

The titles of sections or paragraphs listed below should not be considered for purposes of interpreting the intent of this form; these titles have only been inserted for ease or reading.

This Endorsement applies to the Performers/Cast Coverage Form in the DICE Producers Portfolio Coverage or the Performers/Cast Coverage Form in the MPTV Producers Portfolio Coverage of the Policy, and is subject to the terms, conditions, limitations and exclusions that are applicable to the DICE Producers Portfolio Forms or the MPTV Producers Portfolio Coverage Forms to which this Endorsement is attached.

- 1. For the purposes of this Kidnap, Ransom and Extortion Coverage Extension, the following is added to the definition of covered cause of loss in SECTION VII ADDITIONAL DEFINITIONS:
 - 1.1. Covered cause of loss includes:
 - 1.1.1. The actual or alleged kidnap, hijack or detention of a covered person; and
 - 1.1.2. An extortion threat communicated to you to do bodily harm to a **covered person**.
- 2. For the purposes of this Kidnap, Ransom and Extortion Coverage Extension, the following definitions are added to SECTION VII ADDITIONAL DEFINITIONS and apply in addition to those definitions as well as the definitions shown in SECTION III COMMON DEFINITIONS of the applicable Special Conditions:
 - 2.1. Consideration includes the value of any consideration surrendered, including money, monetary instruments, securities, services or any other property that has tangible value.
 - 2.2. **Detention** means the holding under duress of a **covered person** for any reason by anyone:
 - 2.2.1. Acting as an agent of or with the tacit approval of any government or government entity; or
 - 2.2.2. Acting or purporting to act on behalf of any insurgent party, organization or group.
 - 2.3. Hijack means the holding under duress of a covered person for any reason while traveling in a motor vehicle, aircraft or watercraft.
 - 2.4. Kidnap means the involuntary abduction by force or otherwise of a covered person for the purpose of demanding money or other consideration in exchange for the person's release.
- 3. The following exclusions are added to paragraph 2. ADDITIONAL EXCLUSIONS and apply in addition to those additional exclusions as well as to the exclusions described in SECTION II – COMMON EXCLUSIONS of the applicable Special Conditions:

We will not pay for loss resulting from:

- 3.1. The hijack or detention of any covered person taking part in any political activity or the operations of any security or military force.
- 3.2. The hijack or detention of any covered person due to the failure of you or the covered person to properly procure or maintain required travel documents, including passports, visas, permits and other similar documentation.
- 3.3. The detention of any covered person due to any actual or alleged violation of the laws of a country by you, by a covered person or by any person for whom you or a covered person is legally responsible, unless the detention results from allegations that are deliberately false, fraudulent or malicious and made solely to achieve political, propaganda or coercive effect upon or at the expense of you or a covered person.
- 3.4. Any actual or alleged kidnap, hijack, detention or extortion threat that is part of a series of related acts that began prior to the effective date of this Coverage Extension.
- 4. The following is added to SECTION IV METHOD OF VALUATION and applies to the Coverage Extension:
 - 4.1. We will not consider any of the following to be part of any kidnap and ransom loss:
 - 4.1.1. The amount of any **consideration** surrendered as:
 - 4.1.1.1. A ransom payment resulting from the actual or alleged kidnap, hijack or detention of a covered person; or
 - 4.1.1.2. An extortion payment resulting from an extortion threat.
 - 4.1.2. Expenses incurred in the recovery or attempted recovery of the covered person or any ransom or extortion payments.
- The following Additional Conditions are added with respect to the Coverage Extension. These conditions apply in addition to any conditions in SECTION I CONDITIONS of the applicable Special Conditions or in the General Conditions:

5.1. Confidentiality Agreement

You and every covered person must make every effort not to divulge the existence of this Coverage Extension.

5.1. Additional Duty In The Event of Loss

You must make every effort to verify that any kidnap, hijack, detention or extortion threat has actually occurred.

All other terms and conditions of the Policy remain unchanged.
