This Endorsement is attached to the Farm Buildings and/or Building Equipment – Broad Form, and, except as otherwise provided under this endorsement, is subject to all terms, conditions, limitations, and exclusions of such Form.

Notwithstanding any contrary provision contained under this Policy, the following exclusion is added to paragraph 2. EXCLUDED PERILS of the EXCLUSIONS section of such Form:

Except as provided under the EXTENSIONS OF COVERAGE Section, this Form does not insure against increased costs, loss or damage, caused directly or indirectly:

THEFT OR ATTEMPTED THEFT by theft or attempted theft.

Therefore, sub-paragraph 21.9. Theft or Attempted Theft under paragraph 21. Named Perils of the DEFINITIONS Section of such form, is deleted in its entirety.

All other terms and conditions of the Policy remain unchanged.
