This Endorsement is attached to the Farm Buildings and/or Building Equipment – Named Perils Form, and, except as otherwise provided under this Endorsement, is subject to all terms, conditions, limitations and exclusions of such Form.

Notwithstanding any contrary provision contained under this Policy, the following exclusion is added to sub-paragraph 3.7. WINDSTORM OR HAIL under section 3. INSURED PERIL of such Form:

This Form does not insure loss of or damage:

to metal roofs and/or siding, caused by windstorm and/or hail, unless the damage results in the puncture of the roof or siding.

All other terms and conditions of the Policy remain unchanged.
