LOSS OR DAMAGE BY COLLAPSE OF BUILDING EXCLUSION – INSURED PROPERTY

This Endorsement Changes the Policy. Please Read It Carefully.

Certain words and phrases that appear in bold have special meaning as defined in the form to which this Endorsement is attached.

The titles of sections or paragraphs listed below should not be considered for purposes of interpreting the intent of this Endorsement; these titles have only been inserted for ease of reading.

This Endorsement is attached to the Agricultural Property Coverage Forms, and, except as otherwise provided under this Endorsement, is subject to all terms, conditions, limitations and exclusions of such Forms.

Notwithstanding any contrary provision contained under this Policy, this Policy does not insure against loss or damage caused to insured property covered by any **Agricultural property forms** or any property in storage, owned by the **Insured** or owned by others, and for which direct or indirect damages are due to the collapse of the **farm building** and/or **building equipment** where such insured property or property in storage is housed.

All other terms and conditions of the Policy remain unchanged.
