RATING NOTES

General Rating Notes

Unless otherwise specified, the maximum radius of operations applying to commercial automobiles used for transportation of own goods or goods of others is 80 kilometres, all such transport within Canada*. If the normal radius of operations exceeds 80 km, Interurban rating classes apply**

- * Incidental transport within the USA is subject to a premium surcharge see the Incidental USA Exposure Surcharge for parameters and the amount of the surcharge.
- ** Commercial automobiles normally subject to a maximum 80 km radius of operations will still qualify for commercial rating if:
 - Not more than 2 trips per month exceed 80 km radius;
 - Not more than 10% of all trips made per month exceed 80 km radius; and
 - Radius of operations does not exceed 160 km.

Use/operation of vehicles within Canada that are normally subject to a maximum 80 km radius of operations but that are periodically used or operated beyond this radius may qualify for commercial rating plus surcharge – see the Canadian Radius of Operations surcharge for parameters and the amount of the surcharge.

A maximum radius of operations of 160 kilometres applies where indicated for the class. If this radius is exceeded, Interurban rating classes apply as follows:

Class 62: 161-400 kmClass 63: 401-750 km

• Class 64: Exceeding 750 km

For truckmen hauling general cargo of others use 'Truckmen - NOC' for applicable radius.

Radius distinctions represent one-way distance.

Class Rating Notes

The following rating notes apply where indicated for the class:

- 1. Class 35 rating is based on vehicles which are used infrequently for travel to and from jobsites they are immobile much of the time. Where frequent highway travel is involved or frequent travel between jobsites, use Class 36. Do not use for retail or wholesale delivery.
- Class 33 and 34 rates are based on use of the vehicle primarily on the Insured's premises with minimal highway
 travel. Vehicles that are used for frequent delivery of products are more appropriately rated for that exposure. In
 order to use this class, a private passenger use vehicle must also be insured. Do not use for retail or wholesale
 delivery.
- 3. Vehicles (other than those that carry mail or milk) operated under contract exclusively for one party may be classed as if owned and operated by that party.
- 4. Class 55 is to be used only for vehicles that have very limited on-highway exposure such as trucks used solely on manufacturing premises, farm tractors, lawn tractors, off-highway construction equipment. The maximum road exposure expected is crossing a public road or driving a very short distance such as a farm tractor going from one field to another. PREMIUM DISCOUNTS

Multi-Policy Discount

A 10% discount, applicable to the entire commercial automobile premium, is available when at least one commercial non-automobile policy* for the same insured is written with Intact Insurance Company.

Minimum coverage requirements:

One standard commercially rated vehicle (not solely a recreational vehicle) with a minimum of liability and accident benefits.

How the discount applies:

The discount applies on the final calculation, including endorsement and increased Accident Benefits premium.

Ineligible vehicles:

The discount is not available on classes 61, 62, 63, 64 or public vehicles.
